10:15 am AZ CORS Presentation - Brian Conway AZ Department of Water Resources

10:08 am Brian provided a presentation on the continuously operating reference station network in Arizona. He provided information on what type of stations are in AZ and the connection to the national network. Use cases in ADWR were covered. Details on station locations and the data available for free to users (must be registered); 42 public CORS in AZ – real time and post-processed data available. Expansion of the network is planned; 6 new sites in process. Additional opportunities are being pursued to construct new/replacement CORS at ADOT maintenance yards. Visit https://azcors.azwater.gov to create an account to access/download data.

10:40 am SB1500 (Tom Homan)

10:35 am – Similar federal legislative restricting drone acquisition and use; this is the state version – very similar to bills passed in FL & AR; Driven by cyber security concerns. DJI is specifically noted as a risk. As of yesterday, the bill passed the second committee review. Prohibits state or local agency from acquiring or using drones with Chinese origin. State legislation is concerned about critical infrastructure. Existing investments are not outright banded; could be impacted by FCC licensing.

10:50 am Council meeting debrief and discussion on Committee/Workgroup structure

10:45 am – Jenna shared a high-level overview of the recent Council decision to restructure workgroups. A separate meeting to discuss goals and intent dedicated to this topic was suggested.
