For today, we will review the document as is and then determine best next steps for the next meeting. The group reviewed and discussed updates that were worked on.

Custodianship – reviewed changes; group agreed to reference AZGeo Advisory document on 'authoritative' data. Discussion on owner & sharing someone else's data; need to include proper procedures for sharing authoritative data & referencing the source. Reference the State data dictionary (https://aset.az.gov/sites/default/files/2022-04/P4400%20Data%20Governance%20Organization%20Policy.pdf) for definitions. Steward, managers, data domain stewards rather than custodian.

Metadata – cleaned up language & added guidance for end users; added documentation from AZGeo. Added examples and special considerations for some items – i.e. projections

Citations – include source information (AZGeo metadata standards)

Fitness for use – Reference state policy on data quality (https://aset.az.gov/sites/default/files/P4460%20Data%20Governance%20Data%20Quality%20Policy%202020-10-22%20signed.pdf)
